## How will the co-op's rates be adjusted?

The changes are a 6.5% increase to the monthly customer, peak demand, lighting fixture, and wires charges (but not to the power cost pass-thru). Those changes are expected to increase total system annual revenues by approximately \$1,117,536 or approximately 3.0%. The existing and new rates are:
